## Inquiry report finds risk of immeasurable harm to children from internet (12/03/20)

The IICSA has published its report on the Internet and Child Sexual Abuse.

The report highlights an explosion in child sexual abuse facilitated by the internet; since 2016, approximately 400 to 450 people are arrested in the UK for related offences each month. Despite technological advances to detect and prevent online child sexual abuse, law enforcement is struggling to keep up.

The report shines a light on the scale of child sexual abuse facilitated online, finding that the number of indecent images of children in circulation worldwide is in the many millions, with some images reaching unprecedented levels of depravity. It is still possible to access such imagery from common search engines in only "three clicks". The report concludes that internet companies must do more to pre-screen material before it is uploaded to their platforms and systems.

## Inquiry finds Westminster failed significantly in responses to child sexual abuse (25/02/20)

The IICSA has published its Westminster report, which finds political institutions have significantly failed in their responses to allegations of child sexual abuse for decades.

This includes failing to recognise abuse, turning a blind eye to it, covering up allegations and actively protecting high-profile offenders, including politicians.

During three weeks of public hearings last year, the Inquiry heard from survivors, whistleblowers, cabinet ministers, MPs and police officers among others.

#### Tackling Gangs, Violence and Weapon Crime Conference 2020

In England and Wales, overall crime has been decreasing since 1995, but in the year ending June 2019, there was a 4% increase in the number of police recorded offences involving firearms, and a 7% increase in offences involving knives or sharp instruments (to 44,076 offences).

In Greater Manchester alone, there were at least 13 high-profile incidents involving knife stabbings in October 2019. In the year to June 2019, there were 3,437 crimes involving knives recorded by Greater Manchester Police, up from 2,553 knife crimes in the year to June 2018 – an increase of around 35%.

Additionally, the network of county lines continues to penetrate into towns and villages across the country. According to the NCA's County Lines Drug Supply, Vulnerability and Harm 2018 report, there are over 2,000 individual deal line numbers in the UK, which are linked to approximately 1,000 branded county lines. Increasingly, the perception of county lines as primarily drug-dealing offences is being expanded upon, to include modern slavery and child trafficking.

As such, collaboration and cooperation at every level, across schools,

healthcare and safeguarding, is becoming increasingly important.

The Government's 'Serious Violence Strategy' launched 9th April 2018 set out how to respond to serious violence, and £40m of HO funding was established to better intervene in youth engagement with gangs, establish the National County Lines Co-ordination Centre, and develop understandings of drug-market violence and gang behaviours. Such policies aim to balance preventative and reactive interventions for tackling gangs in a multi-agency format, but its long-term success is yet to be fully seen.

This conference brings together the key stakeholders involved in tackling gang, violence and weapon crime in the UK. With keynotes from senior bodies and case study examples of best practice, attendees will get the latest information and be able to benchmark and gain new insights and strategies on how to best tackle gang crime.
