#### **UKCIS Online Safety Audit Tool** (10/08/20)

The UKCIS Online Safety Audit Tool is designed to help trainee teachers (ITTs) and newly qualified teachers (NQTs) better understand their role in keeping children safe online and their school's policy and practice. It offers opportunities for research as well as reflective questions to accompany ITTs' and NQTs' development as teachers.

£250,000 fund to support service children in schools across Wales (14/08/20)
Ahead of VJ day, the Education

Minister, Kirsty Williams has announced £250,000 to support service children in schools across Wales during 2020/21.

The funding helps schools provide additional support to children from families of Service personnel. The challenges can include the effects of moving from one school to another due to the location of the posting. It can also include the effects of parents or guardians in the Armed Forces being deployed away from home, either on operation or a long term training exercise.

£10m for buses as school transport guidance published (11/08/20)
The Welsh Government has announced an additional £10m to help the bus industry safely transport more passengers to school, college and work.

The Welsh Government has also updated its learner transport guidance so that LAs and bus operators are clear on the steps they must take to ensure that from September children and young people can travel safely to school and college.

The new academic term will see children and young people return to full time school or college for the first time since March. As a result there will be an increase in the number of children, young people and parents relying on bus services to safely transport them to their place of learning or work.

The additional £10m of Welsh Government funding is to help operators manage the increased pressure on scheduled bus services. It recognises that social distancing measures are resulting in reduced capacity and that this in turn is significantly affecting ticket revenue. The additional funding will enable operators to increase the number of buses available while also helping to cover costs associated with additional staffing, fuel and maintenance of the bus fleet.
