#### **Snowdrop Doula**

These last few months have been mega busy and we've had most of our Doulas furloughed due to childcare issues.

We now have all our staff back!

We are currently offering support to families before, during and after birth as usual. Just with a bit of change with not visiting homes as per guidance.

Our support includes birth preparation and information, expectations of life with a newborn, feeding support, peer support, emotional wellbeing support, practical support and anything else that may be needed to support through this period.

We are also able to support those whose children have been or are likely to be removed from their care. This support can be around parenting skills or emotional and practical support depending upon need. We will be also able to offer PAMS assessments in September either alongside side or standalone our parenting support service.

Our Counsellors are still available for any parent, parent to be or prospective parent.

We also have our baby bank and food share scheme. The food scheme is to reduce food waste from local food establishments and shops and help feed local people. We have no criteria for this although prioritise those in need.

We are also opening a new shop in Burnley with preloved and new ethical clothes, goods and foods within the next few weeks. All profits help is to continue our support services

# **Eric Wright Charitable Trust Grant 2020**

The Eric Wright Charitable Trust Community Small Grants programme is aimed at local organisations within the VCF sector providing activity to address locality community cohesion,

reduce social isolation and make a positive difference to the lives and wellbeing of people of all ages. Organisations must have an annual turnover of less than £30,000.

Projects should strongly support specific local needs in the following key areas to successfully qualify for this fund:-

- Increasing opportunities to participate in local community action
- Keeping people well and feeling part of their community
- Increasing resilience and improving mental wellbeing, enabling individuals and families to cope well, overcome barriers to achieving their potential and increase their skills
- Support people who are more vulnerable, such as those with a long term conditions, who are frail and/or have complex needs
- Promotes greater partnership working between the community and general practice, and other VCF organisations
- Reduce social isolation, with a positive impact on health and wellbeing

# Who can apply to The Eric Wright Charitable Trust Community Small Grants programme?

The grants are being made available to community projects in Burnley, Pendle & Rossendale. There is a strong focus for small grassroots groups that are providing effective community cohesion programmes. This funding proactively encourages small groups or new start up groups to pilot their ideas and gather evidence for future funding bids to help sustain the activity/programme. As long as your group meets with the CVS prior to submitting the application to see how we can support your group, then you are eligible to apply.

#### Lloyds Bank Foundation's New COVID Recovery Fund Opens for Applications

Funding to support charities with an income of between £25,000 and £1 million to recover beyond the immediate crisis of the coronavirus/COVID-19 pandemic.

Lloyds Bank Foundation for England and Wales launched a new £7.4 million COVID Recovery Fund on 3 August to support small and medium sized charities in England and Wales that are helping people overcome complex social issues such as dependency, homelessness and domestic abuse.

The Fund will provide 140 charities with a two-year unrestricted grant of £50,000 alongside the support of a Development Partner to help identify and act on any organisational challenges they are facing.

To ensure this funding is distributed equitably, a minimum of 25% of the grants will be awarded to charities led by Black, Asian and Minority Ethnic communities.

Applications will be accepted from 10 am on 3 August to 5pm on 11 September 2020.

#### **Community Foundation for Lancashire Fund**

The Community Foundation for Lancashire, working with UK Community Foundations (UKCF), the National Emergencies Trust (NET) and the Lancashire Resilience Forum (LRF), launched the Lancashire COVID -19 Community Support Fund in March 2020. The overall aim of the fund is to support local voluntary and community organisations that are helping vulnerable people impacted by the Covid-19 crisis. The programme is now transitioning from the initial immediate relief phase to a more long term emergency phase, the definition for which is 'those who are suffering hardship as a result of the short and long term economic and social consequences caused by COVID-19.'

The fund will continue to prioritise projects which directly respond to acute need, particularly in local communities which experience a return to lockdown as a result of a spike in infection. #### **Tesco Announces Final Deadline for COVID-19 Communities Fund**

Funding to support a wide range of community groups, charities, schools and other not-for-profit organisations who are supporting vulnerable groups as part of their coronavirus/COVID-19 emergency response.

In April, Tesco responded to the coronavirus/COVID-19 pandemic by setting up a new short-term fund to support local communities across the UK and to support organisational needs rather than fund specific projects.

Organisations who are supporting vulnerable groups, as part of their emergency response in supporting local communities, still have time to apply for a single payment of £500.

Applications will be welcomed from a wide range of organisations including: voluntary/community organisations, registered charities, schools, health bodies, Parish/Town councils, social enterprises, Community Interest Companies, community councils, local authorities and housing organisations. Other not-for-profit organisations might also be eligible.

Typically, the fund will support organisations that have experienced:

- Increased demand a holiday hunger club needs more resources to support children through the summer months or a food bank whose stocks are running low and needs an immediate donation to enable the food bank to restock.
- Disrupted services a local charity setting up a delivery service to replace its monthly lunch club, or a charity needing to set up a telephone service to support beneficiaries.
- New services a health focused charity having to set up a new online patient service requires new IT equipment or a mental health charity developing a new service.

The final date to submit an application is 18 September 2020.

#### **Tackling Inequalities Fund - Applications Now Open!**

The Canal & Rivers Trust are responding to the Covid-19 pandemic to support communities across Pennine Lancs to keep active during the early lockdown and recovery stages of the Covid-19 pandemic.

The situation is evolving daily and we're shaping our project in response. Applications for funding bids of £500-£10,000 are now open, we're assessing each application as they arrive and making decisions as soon as possible to respond to the pandemic and needs of the community.

Applications received by 12pm on a Wednesday, will be assessed on a Friday. We will then share applications with Sport England who make the final decision.

#### **Local Authority Emergency Assistance Grant for Food and Essential Supplies**

The Local Authority Emergency Assistance Grant for Food and Essential Supplies is a one-off contribution for local authorities in England to use to support people who are struggling to afford food and other essentials due to COVID-19.

Funding has been allocated to upper tier authorities based on population weighted by a proxy measure of need, the Index of Multiple Deprivation. The total allocation for Lancashire is £1,453,005.64.

It is proposed to allocate funding to district councils to enable linkage to existing support mechanisms in place through community hubs. The same funding model as used by DEFRA has been used to allocate funding as detailed in the attached spreadsheet. Funding has to be spent in line with the Government grant guidance

The intended focus of the fund is the direct provision of food and other essential supplies. DEFRA recommends consideration of provision of cash or vouchers for this, however, it is at the discretion of Local Authorities to use the fund to meet the greatest needed.

DEFRA has clarified with us that funding can be passed onto others to support existing schemes that deliver the grant objectives. Schemes will need to assess claims and consider individual circumstances when making decisions to support claims. They will need to accept referrals from across the district.

As a minimum the following monitoring will be required for DERFA:

- financial reporting details on how much was spent and on which interventions.
- what type of support was provided
- the criteria used to assess claims

- the percentage of the fund spent on administration
- the level of demand for support compared to before the lockdown
- the processes that maintained equality and reduced fraud (section 2 of the guidance)

DEFRA has also clarified that the 12 week period is "an expectation rather than a requirement". We will, however be required to provide an evaluation of spend to MHCLG at the end of the 12 week period. LCC received the funding at the end of July, this would take the timeframe to October.

The funding must be spent within the financial year.
