Myths

During international RJ Week we want to dispel some of the common myths about Restorative Justice.

Restorative Justice can only be used as an alternative to court.

♦ MYTH

Restorative Justice can be used alongside ANY disposal for ANY type of crime. If cases are going to court and the victim requests Restorative Justice, we will pick up the referral post sentence.

Restorative Justice is a soft option for offenders.

♠ MYTH

Offenders consistently report it is much harder to sit face-to-face with their victim and have to listen to the way their offence has impacted on their life than it is for them to attend court.

Restorative Justice can revictimise victims if they come face-to-face with their offender.

♠ MYTH

Victims report very high levels of satisfaction with RJ because they feel they are in control, their voice is heard and they are provided with a safe environment to ask questions of the offenders. All conferences are fully risk assessed by the RJ Team and we would never take the victim into a meeting if we felt it had the potential to cause further harm.

If offenders take part in RJ in prison they get a reduction in their sentence, parole or extra privileges.

♦ MYTH

RJ does not result in any advantages or added benefits for the offender. It is however seen as a positive step forward for the offender by the very fact they have taken responsibility for the offence and are making efforts to positively rehabilitate.

A victim has to forgive the offender in order to take part in RJ.

♠ MYTH

A victim does not have to forgive the offender to take part, the process is an opportunity for the victim to ask questions and for the offender to take responsibility for their actions.

The process aims to bring closure for the victim.

RJ can't be used for serious crime and sexual offences.

♠ MYTH

RJ will now considered for **ALL**offences, each case is considered
on a case by case basis with a
multi-agency approach. Such
offences in Lancashire can only be
dealt with on assessment by the RJ
Team.



FEATURE STORY YOUTH OFFENDING TEAM (YOT) BY SARAH CALLON – SERVICE MANAGER

Youth Offending Teams (YOTs) were created by the Crime and Disorder Act 1998 with the purpose of preventing offending by children under the age of 18. They are the key to successful intervention in the lives of children who commit criminal offences and their families.

YOTs are multi-agency teams made up of representatives of the Police, the Probation Service, Social Services, Education and the Health Service. They carry out a comprehensive assessment of children to find out the reasons for their offending behaviour and decide the level of risk of their reoffending. This enables YOT staff to identify suitable programmes to deal with the offending behaviour, with the aim of preventing further offending. YOT staff also work closely with the youth courts and the Crown Courts in providing pre-sentence reports to help magistrates and judges decide on the appropriate sentence to impose on children who are convicted of a criminal offence.

Where a victim has consented for their details to be shared with the YOT, the victim/RJ worker in the service makes contact with them. This ensures that the victim's voice is heard and information regarding their views and needs can be taken into account when planning interventions for the child. It is really important for the YOT to have the victim's voice to inform work with the child so that they have a full understanding of the impact of their behaviour on others. Our contact with the victim also enables them to make informed choices about involvement in restorative processes.

In Blackpool we have completed a variety of restorative processes with victims of crime. These have ranged from letters of apology to shuttle mediation and we have facilitated a number of face to face restorative conferences. Blackpool YOT and Lancashire Constabulary Restorative Justice team have previously completed a successful RJ conference after an incident of anti-social behaviour within the local community resulted in damage being caused to a local children's centre. The two services are currently working together again to facilitate a number of smaller RJ conferences to address anti-social behaviour in a local ears of the town. These conferences will bring together children, members of the local community, third sector agencies and statutory services to explore concerns around anti-social behaviour.



CASE STUDY

A young male has a disagreement with another young male whilst at school and the aggressor assaults the other student in a park outside of the school. The victim sustained injuries including injury to their lip. Both pupils attend at the same school, therefore a positive resolution had to be found. A conference between both males was held at the school by the RJ Team with a positive outcome being reached.

Session comment, noted by PC Steven Russell from conference attendee;

Thanks ever so much for your help in sorting this out. I am really impressed that you have been able to resolve this for everyone in a way that strikes me as being very reasonable and fair to all parties involved. I will definitely look to use RJ in the future as it's a fantastic tool. Thanks once again for all your help, it's much appreciated.



VICTIM AWARENESS COURSES IN LANCASHIRE PRISONS BY CAROL CAINE

Since the start of the pandemic, delivery of the Victim Awareness Courses was suspended in Lancashire prisons. However, I've continued to receive referrals from colleagues in prisons, the majority being from Lancaster Farms.

In order to continue to provide prisoners with victim awareness input we're piloting a new way of working. Those prisoners at Lancaster Farms who're on the waiting list for the group Victim Awareness Course will be issued with a copy of an in-cell Think Victim work book. This work book encourages prisoners to think about their offence; go through what happened; who was there; when it happened and how they and their victims might now feel about the offence. Each prisoner who completes the work book and returns it to me will be offered feedback and once successfully completed they'll be given a certificate.
